The UK Ancestry visa route allows Commonwealth citizens who can prove that one of their grandparents was born in the UK, the Channel Islands, or the Isle of Man to live and work in the UK. This route offers a valuable pathway to live, work, and eventually settle in the UK, with the potential to apply for Indefinite Leave to Remain after five years of continuous residence.

# UK ANCESTRY REQUIREMENTS AND ELIGIBILITY

## GOOD CHARACTER

Applicants must meet basic character and conduct standards, including having a clear immigration history and not posing any concerns to public interest or safety.

## AGE & CITIZENSHIP

Must be aged 17 or above and be one of the following:

- Commonwealth citizen
- British Overseas citizen
- British Overseas Territories citizen
- British National Overseas
- Citizen of Zimbabwe
- Citizen of Gabon
- Citizen of Togo
- Citizen of Eswatini

## ANCESTRY

You must have a grandparent born:

- In the UK, Channel Islands or the Isle of Man
- Before 31 March 1922 in what is now Ireland
- On a UK-registered or UK government-owned ship or aircraft.

## WORK

Applicants must show they are able to work, and intend to seek, and take employment in the UK. Applicants on this route can work in any role, at any skill or salary level, including full-time, part-time, self-employed, or voluntary work.

## FINANCIAL

Applicants must show they have enough money to support themselves and any dependants without relying on public funds. There is no fixed amount required, but adequate maintenance and accommodation must be demonstrated.

# TIPS TO PREPARE FOR YOUR UK ANCESTRY APPLICATION

APPLYING FOR A UK ANCESTRY VISA IS AN IMPORTANT STEP IN YOUR IMMIGRATION JOURNEY. HERE'S A GUIDE TO HELP YOU ENSURE YOUR APPLICATION IS COMPLETE AND ACCURATE.

## GATHER KEY DOCUMENTATION

### Proof of ID & lawful status:

- A valid passport or travel document
- Your full birth certificate
- The full birth certificates of your parents & grandparents
- Marriage certificates
- Name change documents

### Intention to work:

- Job offers
- Business plan if self-employed
- Proof of qualifications
- Previous work history
- Job applications to UK employers
- Evidence of recruitment with a UK recruitment agency

### Financial Evidence:

- Bank statements

## MEET MANDATORY TEST REQUIREMENTS

### Tuberculosis (TB) Testing:

Applicants from countries listed in Appendix T of the Immigration Rules must provide a TB clearance certificate from an approved centre before submitting their visa application to enter the UK.

## PROVIDE ADDITIONAL DOCUMENTS

### If applying with dependants

- Proof of your relationship with your partner and children.
- Additional funds to support your family.

The exact documentation may vary depending on your circumstances, therefore expert advice should always be sought first.

## FAQ'S

### Q: Can I apply for a UK Ancestry visa if I plan to volunteer in the UK?

A: Yes, you can apply for a UK Ancestry visa if you plan to volunteer in the UK.

Voluntary (unpaid) work is accepted as meeting the work requirement under this route. However, since you won't have a regular income, you'll need to show that you can financially support and accommodate yourself (and any dependants) without relying on public funds.

### Q: Can I switch into the UK Ancestry visa from inside the UK?

A: No, you cannot switch into this visa category if you entered the UK on a different type of visa. You must leave the UK and submit an entry clearance (visa) application.

### Q: Can I bring dependants to the UK?


A: Yes, you can bring dependants to the UK on the UK Ancestry visa.

Eligible dependants include your partner, children under 18, and children aged 18 or over if they were previously granted permission as your (or your partner's) dependant. You'll need to provide evidence of your relationship as part of the application.

### Q: Can my dependants apply for Indefinite Leave to Remain at the same time as I do?

A: If your dependants are on a valid UK Ancestry dependant visa and meet the residence and other requirements, they can apply for ILR alongside you.

# PROCESS TIMES

POST BIOMETRIC APPOINTMENT, IT WILL TYPICALLY TAKE THE FOLLOWING TIME TO RECEIVE A DECISION ON YOUR APPLICATION:

<b>STANDARD SERVICE</b>	= 3 Weeks
<b>PRIORITY SERVICE</b> (if available)	= 5 Working Days
<b>SUPER PRIORITY SERVICE</b> (if available)	= 1-2 Working Days within the UK
	<b>£500 Additional Charge</b>
	<b>£1000 Additional Charge</b>

## ONCE YOUR APPLICATION IS SUCCESSFUL

If you applied from overseas after 30th October 2025, your decision email or letter will tell you how to access your eVisa to see the permission you have been granted before you travel to the UK and whether you will get a vignette (visa sticker in your passport).

## WHAT HAPPENS AFTER GAINING A GLOBAL TALENT VISA?

### YOU CAN:

- Work
- Study
- Bring dependants if they are eligible

### YOU CANNOT:

- Change into this visa if you came to the UK on a different visa
- Claim public funds
